How to become a California Certified Florist

Applicants may pursue certification independently or be sponsored by an employer. Sponsored students who attain certification will automatically earn a certificate for their employer. California State Floral Association (CSFA) Cancellation Policy

CSFA makes every effort to hold scheduled workshops and exams, but occasionally, unforeseen circumstances arise such as instructor emergencies, location issues, or low enrollment. If CSFA postpones or cancels your workshop or exam we will provide you with as much advance notice as reasonably possible under the circumstance. Once you are notified of a workshop cancellation, you have the right to reschedule or request a refund. Please keep this policy in mind as you make travel arrangements, as CSFA will not be liable for travel costs.

If you cancel a workshop or exam 7 days prior to class start: No charges incurred. If you cancel 6 days or fewer prior to class start: You will be charged 100% of the class fee. If you register during the cancellation period, the policy is in effect immediately. If you are registered in a workshop and fail to attend, you will be charged 100% of the class fee.
